Restrictions & Limitations:

- 1) Pass is valid for the individual pass-holder only and his/her guest(s) from purchase date (below) through end-date shown above (ID may be required).
- 2) Reservations are strongly encouraged. Availability may be limited due to team/group rentals and lessons.
- 3) Reservations for Personal Pass time should be made at the time of purchase. Any time not reserved at purchase time may be subject to forfeiture if tunnel time is not available when future reservations are attempted.
- 4) Winter Personal Pass time may be split into increments as small as 30 minutes.
- 5) Any unused hours at the end of the duration of the pass will be forfeited
- 6) After initial purchase of this pass, additional time may only be added at the originally contracted rate. Purchase of additional time on this pass will not lower the rate in effect at time of initial purchase.
- 7) Guests (accompanying the pass holder) will not be assessed a "guest fee". Likewise, tunnel time will not be extended for the pass-holder as is customary with the BASES seasonal passes with guests paying a "guest fee".
- 8) Guests are limited to two participating guests per pass-holder per visit.
- 9) Winter Personal Passes may not be used for Team Rental
- 10) Use of the facility by the designated Winter Personal Pass holder is required when guests are present.
- 11) Use of paid instructors in the BASES facility while using the Winter Personal Pass requires a \$10 "instructor fee" for each occurrence up to one hour in duration. BASES management reserves the right to limit or deny Winter Personal Pass use with a paid instructor.
- 12) All Winter Personal Pass holders and guests will be required to have a completed Sandlot or BASES Liability Release form on-file before being allowed to use the facility.
- 13) BASES management reserves the right to revoke any Winter Personal Pass (without recourse of the holder) for failure, on the part of the Winter Personal Pass holder or their guests (paying or non-paying), to conduct oneself with the proper decorum.
- 14) BASES management reserves the right to revoke any Winter Personal Pass (without recourse of the holder) for failure to follow the Restrictions and Limitations stated herein.
- 15) Winter Personal Pass purchased at BASES is valid only at that location.
